



## **B20 BRAZIL PRIVACY POLICY**

B20 Brazil knows how important it is for you to know and feel confident about how we use your personal data on our website. For this reason, we have taken great care to make our policy on the use of this information clear and transparent to you.

This section provides information on the processing of personal data of users visiting the Website <a href="www.b20brazil.com.br">www.b20brazil.com.br</a> (hereinafter referred to as the "Website") and/or using the services within its member's area.

The information is provided exclusively for the Website and not for any other websites that users may visit through the links on the Website.

#### 1. Data controller

As the host of B20 Brazil 2024, the data controller for this Website is the Brazilian National Confederation of Industry (CNI). For more information on the processing of personal data by CNI, please visit:

CNI is exempt from any responsibility for the illegal and unauthorized use of personal data due to misuse or abuse of your access credentials, negligent or malicious conduct, or acts or omissions by the user or a person authorized on the user's behalf.

### 2. Commitment to protecting your data

As data controller, the Brazilian National Confederation of Industry is committed to ensuring the security of your data throughout the entire process of browsing the platforms, using the services, and sending requests through the communication channels available on the platforms.

Personal data will be processed exclusively by the personnel of the Brazilian National Confederation of Industry authorized to carry out the Secretariat of B20 Brazil, who will act based on specific instructions regarding the purposes and methods of processing.





### 3. Categories of personal data and purposes of processing

When accessing the B20 Brazil Website, two categories of data may be collected: (1.1) Cookies; and (1.2) Data provided by users.

Please see below the details of each category, the circumstances in which they apply, and the purposes of their processing.

#### 3.1. Cookies

"Cookies" are small text files sent by the website server to your computer and which are valid for a certain period of time.

Cookies identify the user's computer and obtain data about the pages visited (browser session) or links clicked, allowing the storage of browsing history and user preferences, the collection of statistical data, the customization of the use of the platforms, and the delivery of personalized marketing according to the user's profile.

Cookies are secure, anonymous, private, and used only for your benefit to provide personalized content. Cookies may be processed and used:

- (i) To improve the use of our services and the experience of our users;
- (ii) To carry out statistics, studies, research, and surveys relevant to users' activities and behaviors when using the services;
- (iii) To protect our rights and obligations in connection with the use of the services, including in legal and administrative proceedings;
- (iv) To cooperate with and/or comply with a court order or request from an administrative authority;
- (v) To recommend services or features of the platforms, including third party services, that may be of interest to you; and
- (vi) To direct you to our profile on other websites.

The Website may use cookies and it is up to you to configure your Internet browser if you wish to block them. If you choose to block cookies, some features of the Website may be impaired.

During your access to the platforms, even if you are not registered and/or logged in, we may collect: (i) your IP address; (ii) the actions you take on the Website; (iii) the pages you access; (iv) the date and time of each action and access to each Website feature; (v) information about your location; and (vi) your session ID, when applicable.

In addition, some of our cookies are part of the technological solution and are inherent to the operation of our platforms and applications. Therefore, the choice of whether or not to use them is not optional.





### 3.2. <u>Data provided by users</u>

As a general rule, this Website does not collect any personal data from users when they visit it. It is possible to visit the Website without revealing any personal data, unless you choose to provide such information.

Personal data may be provided by users on voluntary basis to use the services offered on the Website (e.g., B20 Task Force application form). This data will be processed to:

- (i) Allow selection and registration for B20 Taskforces.
- (ii) Provide access to the member's area of the Website.
- (iii) Provide the correct services associated with the member's area of the Website.
- (iv) Follow up on requests made by users.

Users may also provide personal data on a voluntary basis when contacting the addresses indicated on the Website. Registration requires the following personal data from the interested party: Full name, gender, nationality, email address, phone number, job title, Linkedin profile. Such data will be processed by the recipient of the communication in order to follow up on the requests received.

If you are asked for any other personal Information, you will be informed of how it will be used if you choose to provide it. If at any time you believe that any of the principles referred to in this privacy policy have not been followed, or if you have any other comments about these principles, please notify the webmaster via the Contact Us page.

# 4. Storage, retention, and deletion of data

The data may be stored on servers owned by the Brazilian National Confederation of Industry or by third parties appointed for this purpose, whether located in Brazil or abroad, in accordance with applicable legislation, and may also be stored using cloud computing technologies and/or technologies that may emerge in the future, always with the aim of improving and expanding the services. In cases where there is an international transfer of personal data, we will adopt the appropriate transfer mechanisms, as the case may be.

The data will be kept for the time necessary to carry out the activities of the B20 Brazil 2024 Secretariat. In cases where we no longer need your information to provide the services, we will only keep your data for as long as we have a valid legal basis to do so. In some cases, we may keep your data for a longer period, in particular when this is necessary for the establishment, exercise, or defense of any rights.





## 5. Data subjects' rights

Data subjects have the right to access, rectify, update, and delete their personal data held by the Data Controller. They may also request the restriction of processing and the portability of their data. Moreover, if there is reason to believe that processing has been carried out in violation of the personal data protection regulation, the data subject may lodge a complaint with the Brazilian National Data Protection Authority (Autoridade Nacional de Proteção de Dados Pessoais – ANPD).

#### 6. Data subject obligations

At no time during or after the event, may participants record or transmit, by any means, any audio and/or video content of the B20 Brazil process.

This document does not grant any of the participants any right with respect to the intellectual and industrial property rights of the other party, which from now on recognizes that in case of violation of the copyright of other participants, CNI, as well as the copyright holder, has the prerogative to prevent such practice, which, depending on the particularity of the case, may lead to civil and/or criminal liability of the offender, in accordance with Brazilian laws (Law 9.160/1998, and articles 186 and 927 of the Civil Code and 184 of the Penal Code).

## 7. Changes to this Policy

The Brazilian National Confederation of Industry may modify the provisions of this policy at any time and at its sole discretion. Any time the policy is materially changed, such changes shall be valid, effective, and binding upon:

- (1) being published on the platform;
- (2) being sent by email to users who have consented to provide personal data; and/or
- (3) being communicated to users by any other means.
